PHILIPPINE VISA INFORMATION

1 VISA ISSUANCE

The granting of Philippine visa is in effect, only a form of pre-entry clearance. Immigration Officers have the authority to grant or deny admission. Visa holders are subject to normal immigration control at the port of entry.

2 VALIDITY OF VISA

The period of validity of a visa indicates the time within which entry into the Philippines may be effected. It does not refer to the length of stay in the Philippines. Those who intend to stay for more than 59 days may apply for an extension of their visa with the Bureau of Immigration and Deportation in Manila or in major cities. A minimal fee is collected.

3 GENERAL VISA APPLICATION REQUIREMENTS:

For stay of not more than 59 days

- a. Application Form;
- b. Passport with validity of at least six (6) months after the intended stay in the Philippines;
- c. Photocopy of data page of passport;
- d. One (1) recent photograph, with signature at the back;
- e. Work permit and stay permit
- f. Proof of financial capacity (bank statement for last 6 months, etc.)
- g. Photocopy of a roundtrip airline ticket, valid for his/her return to country of origin or onward travel to the next country of destination
- h. Letter of invitation stating the nature of travel, designation / position of the applicant and inclusive dates of travel;
- i. Official travel - Note Verbale from the Ministry of Foreign Affairs, or sending foreign Embassy stating the nature of travel, designation/position of the concerned official and the inclusive dates of travel.

**** Note: Additional documents may be required by the consular officer from the applicant upon evaluation of the requirements.***

4 FILING OF VISA APPLICATION

Application for a temporary visitor's visa must be made in person. In case of a minor below 18 years of age, the application may be made by any person who, in the opinion of the consular officer, is responsible for the child's welfare.

5 VISA FEES

Single entry, valid for 3 months from the date of issue is US\$30.00 or US\$40.00.
