**REQUIREMENTS FOR THE APPLICATION OF MARRIAGE LICENSE  
(For marriage solemnizing at the Embassy)**

1. Personal appearance of the contracting parties;
2. Accomplished form for application of marriage license;
3. Original valid passports of the contracting parties with photocopy of data page;
4. Original PSA-issued Birth Certificate authenticated/apostillized by the DFA;
5. Original PSA-issued Certificate of No Marriage (CENOMAR) authenticated/apostillized by the DFA;
6. Affidavit of Parental Consent executed by both parents (*required only for applicant between 18 to 21 years old*);
7. Affidavit of Parental Advice executed by both parents (*required only for applicants between 21 to 25 years old*);
8. Fees:

• Affidavit for application of marriage license	US\$25.00
• Marriage License	US\$25.00
• Solemnization of Marriage/Certificate of Marriage	US\$60.00
• Report of Marriage	US\$25.00

**Reminders:**

- The Marriage License will be issued on the **11<sup>th</sup> day** after the 10-day posting period (**Notice of Marriage**) upon submission of the application for marriage license.
- Validity period of Marriage License is **120 days** (Solemnization of Marriage can be scheduled within the said period)
- The contracting parties may provide designs/arrangements inside the Embassy's premises where the solemnization will be held.
